VICTIM PROFILE:

A young woman, her husband and son came to Charlotte with the assistance of a local social services agency. Soon after beginning life in the United States, the husband began to physically abuse his wife. Thousands of miles away from her home country, family and friends, and unable to speak English, this woman found herself alone and paralyzed with fear about how she would provide for her young son and live in a country so foreign to her.

Using an interpreter, UFS diligently worked with the woman to help her start a life independent from her abusive husband. Unfortunately, the woman's social worker at the local social services agency refused to assist her because of an allegiance to the husband. After UFS demanded a new social worker for the woman, she was able to secure a steady job. UFS also helped her find childcare so she could work and become financially independent. UFS' relationship didn't end there. They helped her find an apartment and were able to secure a deposit and one month's rent for the woman through the Department of Social Services.

Today, the UFS client is speaking English and using public transportation to get to and from her job. This woman found the courage and strength to flee a life threatening relationship and begin a new, safe life for herself and her son.
